Are you wondering if your child is 2e (twice exceptional: gifted with a disability like ADHD, dyslexia, visual processing issues, etc.)? Do you have a diagnosis for your child and know he or she is 2e? Check out this [JAGC web page](#) with resources to help you.

Become a JAGC Ambassador

[JAGC Ambassadors](#) are parent volunteers who receive training in how to serve GT students, parents, and staff at the articulation area and school building levels. Ambassadors can serve neighborhood schools, charter schools, home school groups and preschools.

Ambassadors help develop strong family-school partnerships. The process can be tailored to each school and Ambassador according to motivation and availability. An Ambassador's process for building successful partnerships and programs usually consists of raising awareness, taking positive action to cultivate involvement and celebrating successes.

Short on time? This is an understandable concern and we don't want anyone to feel overwhelmed. First, you don't have to be an expert. An easy-to-use [Online Training](#) is available that you can do anytime. Second, one of the main functions of an Ambassador is to get GT information (which we will provide to you) to members of your school community (newsletters, websites, Friday Folders, etc.) Third, you can always share the role with others in your school or articulation area. Legislative News - Call to Action

The Javitz Grant, which totals \$12 million in its budget, is the only federal money for Gifted and Talented students. The current administration's budget proposal for 2020 proposes that this funding be cut. NAGC has made a [position statement](#) on this, which may be of interest to our readers.

A call or letter to your congressmen may be of help to alert them to this inequity. If you feel inclined to educate them about the needs of the gifted, you may want to add the following facts:

- Most developed countries give significant funding to their gifted programming, recognizing these students as a resource for their country's future. US does not provide such generous funding.
- Studies suggest that No Child Left Behind has left gifted students behind. While NCLB was valuable legislation, the gifted are a recognized group under the Every Student Succeeds Act warranting appropriate services also.
- Roughly 20% of high school dropouts are gifted students, (while they represent on average 5 - 10% of all students). Lack of challenge is a frequently cited reason for students' decision to drop out.
- 20% of the prison population is identified as gifted.

Colorado Association for Gifted and Talented (CAGT) is pleased to announce the [2019 CAGT Youth Impact Award](#). This award (formerly known as the Distinguished Student Award) is designed to recognize in children ages 7-18, who have made a positive, meaningful, and beneficial impact on others in their classroom, school and/or community. New this year CAGT will be choosing four children from the state of Colorado who will be named CAGT Youth Impact Award Students: one student for the Junior Division (ages 7-9), and one student for the Senior Division (ages 10-12), and two students for the Masters Division (ages 13-18). All four students who are selected will receive a CAGT Certificate of Excellence and a cash reward.

CAGT encourages teachers, families and community members to recommend past or current students for this honor. The awards will be presented at the 2019 CAGT Annual Conference Awards Night this fall, which will be held at the Embassy Suites in Loveland, Colorado on the evening of October 21. CAGT will publish the names of the Youth Impact student winners in the conference program and the CAGT newsletter, *The Kaleidoscope*.
